## **Guiding Principle Statement**

Topic: What We Believe at SAM

- 1. How do the values in our Guiding Principle Statement (safety, respect, inclusion, restorative practice, dignity, collaboration) align with your hopes for your child's learning environment?
- 2. What role do you think families can play in reinforcing these principles at home? What supports or tools would help you do this more effectively?
- 3. When your child experiences a challenge at school, what approaches have helped you feel heard, supported, and part of the solution?

## **Guiding Processes Framework**

Topic: How We Respond to Behavior

- 4. After reviewing our tiered approach to behavior (Minor, Moderate, Significant, Severe), do you feel the responses outlined are fair and appropriate for each level? Are there any areas you'd like clarified?
- 5. How can we better communicate with families when behavior concerns arise—what methods and frequency of communication feel supportive rather than reactive?

Topic: Broader Perspectives and Support

- 6. What types of support—either proactive or in response to behavior—do you believe have the most impact on helping children learn and grow from their mistakes?
- 7. Are there school-wide programs or values you think could be further emphasized to promote positive behavior (e.g., student leadership, peer mentoring, wellness initiatives)?
- 8. How do you think SAM could continue strengthening its partnership with families when it comes to supporting student behavior and well-being?

## SAPS Presentation to the City of St. Albert Council Meeting

The Alberta Government announced the \$8.6 billion School Construction Accelerator Program to build 90 new schools and modernize/replace 24 schools 2025-2027. Kristi Rouse presented to City Council the importance of having school sites ready and meeting the Governments 'check-list' to have St Albert Public approved for a new school build. We asked the city to approved the Area Structure Plan in the North East and help us have a school site larger enough for a new high school. The city approved the ASP's first reading on Nov 5<sup>th</sup>.
